In the event of a delay in schedule due to photographically unfavorable conditions, or reasons beyond its control, Producer may reschedule as agreed to by the Property Head.

Producer may photograph, film, videotape and record sound on the Property and use the resulting materials in any way Producer chooses. Property Head grants Producer permanent, worldwide, exclusive right to own all rights to all that Producer records and photographs.

Producer may bring into the Property crews, actors and equipment. Producer may construct temporary sets and, after completing photography and recording, will restore the Property to its original condition as of the initial date of occupancy unless otherwise agreed to by both parties in writing, reasonable wear and tear excepted.

Producer agrees to follow the policies, rules and regulations of the Pennsylvania Historical and Museum Commission and will cooperate and coordinate its Production at all times with the Property Head.

Producer agrees to hold harmless, indemnify, and defend the Commonwealth of Pennsylvania, Pennsylvania Historical and Museum Commission ("Commission"), its directors, officers, agents, servants, volunteers and employees from and against all losses or liabilities, demands, claims, actions, causes of action, damages or expenses of any nature whatsoever, regardless of the merit or outcome of any such claim or suit, for death or personal injuries, damages or losses to any person or persons or property suffered or sustained by anyone in, on or about the Property or any part thereof, or any improvements thereon, arising out of or in any way connected with Producer's activities on the Property or with the use of the Property by Producer or anyone on or in its behalf, or the construction of any improvements, excluding those damages attributable to the sole negligence or willful misconduct of Commission. Producer represents that they are covered by Public Liability and Property Damage insurance. This release shall be interpreted in accordance with and governed by the laws of the Commonwealth of Pennsylvania.
