Our first stop of the day is the Brandywine River Museum which is opening early exclusively for our group! Before the museum opens to the public, visit the extensive holiday model train display and enjoy a continental breakfast including assorted pastries, yogurt, and fruits. You will then have additional time at the museum to continue exploring the many fascinating exhibits.

Next, enjoy a delicious Sunday brunch buffet at the historic Mendenhall Inn. The property on which the present Mendenhall Inn is located was one of three parcels given to William Penn's daughter, known as the Letitia Penn grant.

Travel to the Wilmington & Western Railroad's Greenbank Station where we you'll board your train and depart on a 1 1/2 hour round trip

Santa Claus Express train. You'll travel between Greenbank and Ashland and may even catch a glimpse of Mr. Claus, himself! **Your train will be powered either by a historic first-generation diesel locomotive or by an antique steam locomotive.*

After your return to Greenbank Station you'll have some time to visit the station gift shop and take photos before boarding your coach and traveling back to Central PA.
