7:00AM - Motorcoach will depart from Lancaster area pick up location, location TBD

8:00AM - Motorcoach will depart from AAA Central Penn, 2301 Paxton Church Rd, Harrisburg for New Freedom, PA

****Departure times are approximate and will be confirmed closer to date of travel.**

Arrive at the Northern Central Railway Station and enjoy exploring the NCR property as your train prepares for a special run by for the group. Then, board your train for a 1 hour round trip ride from New Freedom, PA to Glen Rock, PA on a diesel locomotive*. Historic narration of the history of the towns along the track will be presented by the conductors. Upon return to the station, disembark the train and visit a local restaurant situated next to the train tracks for lunch.

Following lunch, your day continues as you journey to Walkersville, MD. Upon your arrival to the Walkersville Southern Railroad station, depending on the train schedule, you may have the opportunity to watch the crew shoveling coal onto the locomotive, or watch as the locomotive moves from the train yard to the station. Then board a steam locomotive* for a 70-minute round trip ride through picturesque Maryland farm country. An open flat car is expected to be directly behind the steamer, plus several enclosed cars behind.

Next, travel to Glen Rock, PA for an included dinner stop at the Glen Rock Mill Inn. Enjoy a buffet dinner at this historic, upscale restaurant located in a 200-year-old wool mill, turned restaurant and hotel. After a delicious dinner, return to Central PA.
