5:00AM - Motorcoach will depart from AAA Central Penn, 2301 Paxton Church Road, Harrisburg.

6:00AM - Motorcoach will depart from Penn Cinema, 541 Airport Road, Lititz; travel to New York with a rest stop en route.

Next, we'll meet our local top rated tour guide to tour the **Grand Central Terminal**, where we'll discover the many secrets of this New York City Icon. Did you know that close to a million people pass through Grand Central Terminal every day, yet very few know the many stories and secrets which you will learn on this tour. View the terminal's previously private Campbell apartment which is featured on this tour along with the history and beautiful architecture.
